
2016 MONTAGUE OPEN SPACE AND RECREATION SURVEY – DRAFT RESULTS



Question 9: Do you support adoption of the Community Preservation Act in Montague? (To allow the Town to raise money for land conservation and recreation, as well as community housing and historic preservation, through a property tax surcharge of 1% - 3%. The first \$100,000 of residential property value and low income residents can be exempt from the surcharge. Towns that adopt CPA may also receive state matching funds. For a house valued at \$200,000, a 1% surcharge = \$17/yr.; a 2% surcharge = \$34/yr.; a 3% surcharge = \$51/yr.)



If you look at the kayakers in the area, you will see that a good portion are OLDER. The river from Sunderland to Montague is designated a wildlife corridor with max power speeds of 10 mph. It is IDEAL for older kayakers but we need EASY access. Gentle grade to the water near Water Treatment?

There is no longer shade, and Lake Pleasant lost the cool breeze that made summer more tolerable (not it is more like hot breath coming from the plains).

- Please make a pool handicap accessible with a lift or a walk in ramp vs stairs
- Thanks for the work you do!
- I'm proud of the outdoor recreation spaces Montague provides already. I think maintaining and education is important to help people care and maintain these spaces for years to come.
- I'd like to see zoning laws changed to allow for Co-Housing models of development where houses are built close together in a neighborhood style and lots of open space is conserved as surrounding area.
- We want more access to the river. It is ridiculous to live on a river and not have access from Turners Falls.
- You are not qualified or have the right to run the programs you have now. Shut them down dammit!

- North St. conservation area has had parking problems. The street has no parking signs all along it, but are
 ignored. During peak use cars are parked all along the street abutting the entrance rather than walk from
 the town common where parking is permitted. Very few tickets are issued.
- Would like to see more upkeep of and playground equipment from old school returned to Montague Center ball field as promised

 Check out the brown field at the end of Masonic, or work with the Masonic Lodge to use some of their land?


Question 11: What is your age?

Question 12: How long have you lived in Montague?




